I further understand that, while volunteering in the Program in any position that requires background screening as a condition of employment, I must immediately notify Angela Oxford, Co-Chair of Service Learning Initiative by calling 479-575-4791, of any arrest and any changes in my criminal record involving any of the above listed provisions or similar offenses of another jurisdiction whether a misdemeanor or felony. This notice must be made within one (1) business day of such arrest or charge. Failure to do so could be grounds for your termination with the Program.

I acknowledge and affirm that I have been provided a copy of University's policy regarding minor-aged children at the University <http://vcfa.uark.edu/policies/fayetteville/vcac/2171.php>. I have read the University's Child Maltreatment Reporting Policy and agree to mandatory reporting of any suspected child maltreatment as outlined by the policy.

I further agree to indemnify the Board of Trustees, the University and its officers, agents, employees and representatives for any damages or claims that may be asserted resulting from my failure to follow the University's Child Maltreatment Reporting Policy, state or federal law; failure to take reasonable precautions to ensure the safety of minors while participating in the Program or while otherwise under my care or supervision; or failure to disclose any arrest or conviction for the offenses identified in this Declaration or in the manner specified herein.

I attest, under penalty of perjury, that I am above 18 years of age and have read this Declaration carefully and state that my attestation here is true and correct and that my record does not contain any of the above listed offenses. I also understand that it is my responsibility to obtain clarification on anything contained in this Declaration which I do not understand prior to signing. I am aware that any omission, falsifications, misstatements or misrepresentations may disqualify me from consideration in the Program and, if I am selected, may be grounds for termination or denial of an exemption at a later date.
